I hope you and your families and friends stay well and I look forward to seeing you remotely, and when allowed, in person again soon.


### Meeting reports - Kirsty Hassall

#### Update of the new BIR website - Daniel Farewell

Progress continues on the development of our new regional website. As you may remember, the BIR is part of an exciting pilot project that will soon allow regions of the IBS to maintain microsites within the extensive infrastructure developed to support the new IBS website. Existing content from our old site has largely been migrated to the new microsite, and the membership management component is also now live.

The remaining challenges to solve include establishing the administrative capabilities to handle registration at regional society events and determining the most secure and convenient way of receiving online payments. While these are not inconsiderable tasks, the IBO are working hard to deliver a site that will be of great value to our region for years to come, and perhaps more importantly will offer newer or smaller regions an excellent foundation around which to grow their community and activities.

#### Member Spotlight—Professor Jane Hutton

I was blessed to grow up with life in all its fullness. South African wildlife and landscapes have so much varied beauty. My mother worked with local people to establish organic vegetable gardens in Soweto, to address problems of malnutrition. There were many arguments about differences between people, and the role of nature, nurture and politics.

I was always going to have a career in mathematics, which I loved from an early age. This naturally lead to statistics interacting with living things: biometry. I left engineering to my brothers. For my master's dissertation, I hoped to study animal populations, but instead did a very interesting medical project which included studying treatments for premature babies. My PhD was in environmental statistics, modelling the flow of water in dry rivers. As I got a job in medical statistics, I have mainly worked in that area. To think through questions about what causes disease and use of personal data, I wrote some article about ethics. Research on survival of people with cerebral palsy resulted in my becoming an expert witness.

It is interesting to see how different disciplines collect and evaluate evidence. My master's study of premature babies and my interest in ethics turned out to be relevant in a legal case. Biometry has provided me with opportunities to interact with many disciplines which relate to my childhood enthusiasms. Another privilege of academic career is international travel and collaboration.

My time is now divided between research, expert witness work, service on grant awarding bodies and committees and a little teaching. As I've acquired more responsibilities, I have had less time to teach, and mainly supervise dissertation students. It is a pity seniority tends to take one away from lectures and tutorials, and the challenge



of explaining ideas and answering the questions of energetic and enthusiastic young colleagues. However, one special teaching stream is working at the African Institutes of Mathematical Sciences, which have students from all over Africa in a glorious multinational, multicultural, multi-faith collaboration.

I really appreciate BIR and IBS, which allows me to see something of statistics in agriculture, ecology, climate, and to learn approaches which help me in health care research, and to keep meeting people who share my interest in mixing statistics into life.

### Member spotlight—Dr John Addy

I am a Postdoctoral Training Fellow in the Malaria Immunology Laboratory at the Francis Crick Institute. My current focus is understanding the human immune response to the malaria parasite using large epidemiological and RNA sequence datasets. I also research the development of sampling methodologies to account for confounding spatial effects and to better understand the development of immunity to infectious diseases.

Prior to my post-doctoral work, I completed my PhD in the Applied Statistics group at Rothamsted Research. Funded by the Lawes Agricultural Trust, I studied the effects of climate change on crop production using historical data from the Rothamsted Long-Term Experiments. My subsequent publications have indicated that historical datasets provide insight into the impacts of climate change on crop production.

The IBS has provided me an environment to meet other statisticians and share ideas about data analysis. These meetings have proved vital to me as an early-career statistician, providing insight into a career in the application of statistics in agricultural, medical or ecological research. I have enjoyed attending meetings at local, regional and international levels. The 2018 International Biometric Conference in Barcelona introduced me to the international network of applied statisticians and the important work we do around the world.
