Young Biometrician Award

We are delighted to announce that the 2015 Young Biometrician Award has been won by David Robertson of the MRC Biostatistics Unit in Cambridge, for his paper "Correcting for bias in the selection and validation of informative diagnostic tests" published in Statistics in Medicine (2015, Vol 34, pages 1417-1437). The judges commented that "The paper provides an accessible and valuable approach to an important biostatistical problem. The development shows an impressive grasp of the practicalities of the issues involved, as well as a mastery of highly appropriate methodological techniques which, although well-established, are seldom seen nowadays." The award includes a diploma and a prize of £1000 and will be presented at a BIR meeting in the autumn (details will appear on the BIR website in due course).

The panel of three judges comprised Professors Michael Kenward (London School of Hygiene & Tropical Medicine, representing the Fisher Memorial Trust), John Matthews (University of Newcastle upon Tyne, representing the BIR) and Ørnulf Borgan (University of Oslo, Norway, international judge). The judges commented that all the entries were of a very high standard. In coming to their decision they considered: the statement made by the nominator about the conduct of the research; the importance of the problem addressed and the understanding of the underlying biometrical issues demonstrated in the paper; the merits of the paper both in terms of technical skill and exposition; and the applicability of the research to the biometrical problem investigated.

The award is a joint venture between the British and Irish Region of the IBS and the Fisher Memorial Trust (http://www.senns.demon.co.uk/FisherWeb.html). It is awarded once every two years, and members of the BIR within 5 years of completing their full-time education (including PhD studies) are eligible to be nominated.

President's corner

I notice that I concluded my previous President's Corner by looking forward to the Channel Network Conference hosted by the Dutch Region in Nijmegen in April. I was right to look forward to the conference because it was an excellent event on all fronts. The talks were all of a very high standard and covered a bewildering array of topics, from clinical trials to genomics to population estimation. The organisation was first-rate, the facilities were good and Nijmegen was a very attractive and historic location. The weather was very kind and so warm that the evening boat trip on the River Waal to where the conference dinner was held was very pleasant indeed.

There was, of course, a strong attendance from the Dutch Region but there were many from other parts of our Society, with the British & Irish Region being the most numerous contingent after the hosts. Part of the attraction of this conference is that it is not a massive event, such as ISCB or JSM, so has a much more relaxed



and convivial atmosphere. But nor is it parochial, with many opportunities to meet with colleagues from the Channel Regions and also from other Regions: it is an excellent use of the Channel Network and one to be actively supported in Belgium two years from now.

Our programme this year has a definite conference flavour, as the next meeting will be held jointly with the RSS as part of their conference in Exeter. Dan Jackson and Daniel Farewell have put together what promises to be a very interesting session on stratified medicine, which will be held in the afternoon of 8 September. The afternoon concludes with the Campion Lecture, when Professor Scott Zeger will also talk on this theme. While the Region frequently holds joint meetings with RSS Sections, involvement with a full RSS conference is much rarer and allows us to reciprocate for the RSS's involvement with the IBC, where RSS read papers have occasionally been presented.

Over the last few weeks a number of you have been kind enough to agree to act as champions for the Region in your local area. While we have growing coverage, there are still gaps and it will be a little while before the network is as comprehensive as I would like. In the meantime, please do try to respond positively if you are contacted. For those who have responded — we haven't forgotten you, please be patient while we try to build up the rest of the network!

The Representative Council represents the IBS membership and is the forum for interaction between the regions and the International Society. Council members must be able to represent the views of their region and so BIR representatives are automatically members of the regional committee.

Plans for the next IBC are now well underway. The conference will take place at the Victoria Convention Centre in Victoria on Vancouver Island (British Columbia, Canada) from 10-15 July 2016. - Methodology in Stratified Medicine by Frank Dondelinger (MRC-BSU Cambridge).
