## President's corner

The label Biometrics includes a large number of areas, many of which have expanded considerably in the last 20 years. Apart from the perhaps more traditional areas of medical and agricultural statistics, one should now include statistical aspects of genetics, genomics, ecology, biology and environmental sciences, to mention just a few. Clearly the British and Irish Region (BIR) cannot hope to 'cover' all these areas effectively.

Members will not necessarily look to the BIR to provide up-to-date meetings in their own areas of special interest. For example, in my own area of medical statistics, I know of specialised UK-based meetings on statistical methods in clinical trials, epidemiological methods, causal analysis, and methods in meta-analysis, amongst others. Such specialised meetings may well be people's first choice when deciding what to attend or what to contribute to. As the world of Biometrics becomes more diverse and subdivided into specialties, where should BIR as an organisation focus its efforts?

I think the answer must be to concentrate on more generic methods or concepts, which have applications across a range of areas. We are attempting to do this. Examples of past BIR meetings of this type include those on GLMs and their extensions (November 2012), a meeting on [software interoperability](#) (November 2013, described herein), and in the future a meeting on [Big Data](#) (September 2014, described herein). These topics were chosen through BIR committee discussions, but of course we would welcome other ideas from members for suitable generic and/or topical issues.

The international bi-annual conference ([IBC27](#), July 2014 in Florence, described herein) is an occasion where, in one place, a wide variety of methods and applications across the full range Biometrics are presented and discussed. It is therefore an opportunity to discover how recent developments outside your own specialised area may be useful in your own work. So I encourage you to attend the IBC, in particular, as well as the other BIR meetings planned, as described in this newsletter, and look forward to welcoming you there.

## Meeting on Species Distribution Modelling

On 9 October 2013 the British and Irish region held a joint meeting with the Environmental Statistics Section of the Royal Statistical Society and the Computational Ecology Special Interest Group of the British Ecological Society on Species Distribution Modelling (SDM) at Charles Darwin House in London. There were four invited speakers: Richard Pearson (UCL, London), Colin Beale (University of York), Mark Brewer (Biomathematics and Statistics Scotland), and Greg McInerny (University of Oxford / Microsoft). The day started with an excellent workshop on “Best practice in SDM”, where the four invited speakers and two of the organisers, Matthew Smith (Microsoft) and Alison Johnston (British Trust for Ornithology), were asked to recommend essential pieces of advice as to what constitutes good practice in SDM.

Following this, each speaker gave a 45 minute presentation; Richard Pearson spoke on “Some contrasting examples of SDM applications in the study of evolution, ecology and conservation”, Colin Beale gave some insight on the “Emerging issues in SDM”, Mark Brewer talked on “Climate Envelopes for SDM” and the day was rounded off with Greg McInerny talking on “New quantitative methods for SDM and making them relevant to users”. The meeting ended with a group discussion.

## IBC 2014, 6-11 July, Florence: Call for Contributed Papers



There is still time to submit abstracts for contributed oral and poster presentations to be presented at IBC 2014. These can be submitted online until 16 December 2013 inclusive. Submissions are welcome in all areas of biometry and an indicative list of areas is given in the full Call for Papers, see the IBC2014 website.

All submitted abstracts will be reviewed by the scientific committee for the conference, and presenting authors will be informed of the status of their abstract (oral session, poster session, rejection) by 3 March 2014. Regis-

tration for the conference opens on 8 January 2014, with an early-bird deadline of 31 March 2014.

Following on from the success of the awards made at the last three IBCs, the IBS will again be awarding prizes for the Best Student Oral Presentation(s) and the Best Poster Presentation(s).

## IBS Young Statistician Showcase Awards

As one of the new initiatives to promote IBS activities among young statisticians, the IBS Executive Committee has set aside funds to encourage their participation in the next IBC 2014 to be held in Florence, Italy. Five grants consisting of \$3000 will provide travel and accommodation expenses for five young statisticians. Grant awardees will give an oral presentation based on their research work in a specific session of the conference called "Young Statistician Showcase".

Applicants should meet the following criteria:

- Applicants should be registered for a graduate or postgraduate degree and be younger than 35 years at the end of 2013 to be eligible to apply. Graduates with one of these degrees in 2011 or 2012 are also eligible.
- Papers submitted must be no longer than 4 pages and must contain original work that has not yet been published, has not been the subject of any other award, and is predominantly the student's own work. The student applicant has to be the leading author of the paper.
- Results of particular studies apply only if the analysis has methodological implications or shows a novel and interesting application of statistics to clinical, epidemiological, or biological data.
- Only one paper per student will be accepted.
- Applicants should be student members of the International Biometric Society.

## Meeting on the theme of “Big Data”

The BIR will hold a meeting on the theme of “Big Data” on 17 September 2014 in London. The aim is to bring together a set of researchers with applied and/or theoretical work in large scale dataset analysis. The meeting will try to highlight links and shared methodological challenges across different research areas. The four confirmed speakers for the afternoon are: Thore Graepel (Microsoft Research; analysis of data from social media, in particular “Facebook likes”), Jaakko Peltonen (Aalto University, Finland; large dataset visualisation and interactive search), Thomas Thorne (University of Edinburgh; analysis of large scale genomics datasets) and Finn Lindgren (University of Bath; statistical methods for very large datasets). More details will follow as we get closer to the event.

## Meeting on Statistical Software Interoperability

On 14 November at the RSS headquarters in London, the BIR hosted an afternoon meeting on Statistical Software Interoperability in conjunction with the Statistical Computing Section of the Royal Statistical Society (RSS). Preceded by the AGM, the meeting featured four presentations from leading figures in computational statistics giving talks on new developments that involve interop-



erability between statistical software packages. William Browne (University of Bristol) started the meeting with “What, why, when and how? The Stat-JR experience”; a thought-provoking tour of various attempts in the past to create interoperability between statistical software and the development of a Model Exchange engine using the Stat-JR software environment. Ian Cox (JMP Marketing Manager, SAS) then gave an eloquent talk on “The interoperability of statistical software in a commercial setting: some personal experiences and observations”, where Ian presented the statistical discovery software JMP; a software product within SAS. After the break Darren Murray (VSN International) talked about “GenStat and ASReml as components of the statistical toolkit” and the day was rounded off with Mike Smith (Pfizer) giving a fascinating insight in “An adventure of running BUGS from other software packages”. ## Statistical Analysis of Multi-Outcome Data Workshop

shop will bring together international researchers in statistics and biostatistics. The topics of the workshop are intended to be broad and cover

- Joint longitudinal and time-to-event models
- Two-stage models
- Landmarking
- Multiple biomarker and survival models
- Novel approaches to modelling longitudinal / survival data
- Causal inference for survival with time-dependent co-variates
- Competing risks
- Recurrent events and survival
- Informative observation times
